Minutes, USMA '58 EXCOM, December, 2020

The EXCOM met virtually via telecom. Present were Jack Bradshaw (President), Andy Andreson (Chairman), Jack Downing, Pete Trainor, Bob Hayden, Audrey Webb, Lee Miller, Mike Mahler, Mike Daley, Tom Sands, George Lawton, and Pete Penczer.

Financial Report (Lee Miller) As of the end of November, the Class Admin Fund had assets of \$29,013. The Class Gift Fund had assets of \$93,674. Both funds had modest increases since the last reporting period.

Lee said he is having difficulty in some cases getting in touch with the next of kin regarding family wishes concerning the \$100 the class provides for either flowers or contribution to some organization. These are monies drawn from the Class Admin Fund.

Lee clarified the long term ownership of both funds.

- The Class Admin Fund will eventually be turned over to the Perpetual Endowment Committee to provide for necessary admin functions. The PEC has no operating funds of its own until that time.
- The Class Gift Fund will be melded into the Superintendents Fund at our 70th or 75th reunion.

New Orleans Mini (Tom Sands). The very small group that traveled to New Orleans had a grand time—Barbara and Tom Sands, Bill Shepard, and Bill and Oksana Stambaugh are shown in the group photo.



Tom's full report on the mini is at Appendix 1. It is worthwhile reading, and you can imagine the fine time the class would have had if Tom's planning had been fulfilled.

Tom's thoughts are that we could revisit New Orleans as a future mini site. Or perhaps San Diego suggested by Bill Shepard. But all agreed that any planning should be put off until a post-pandemic date. The Chair seconded the idea that there would be no 2021 mini until COVID is settled.

The committee was grateful to Tom for his patience and flexibility.

George Sibert's Black Book. (*Frank*). George's famed record of the class is safely put away along with the bottle of the Class's Armagnac. The book has been scanned and copies have been provided to Pete Penczer and Margi Downing. Pete Trainor will post a copy of the book on the

class web site. Alternatively anyone that would like a copy, contact Frank and he will send a pdf (150MB).

60 Plus Ten White Paper. (Frank) Frank sent a mark-up of the paper that was developed for our 60th Reunion to the committee members. He asked EXCOM members to review it so we can consider revisions at the next EXCOM meeting. The paper is posted on the class web site. Frank asked that comments and corrections be forwarded to him in text citing the specific section the comment applies to).

Transition of the Perpetual Endowment Committee. (George Lawton) George discussed the phased plan for governance. It transitioned to Phase 2 some years ago with the introduction of class descendants as board members. Currently Valerie Coffey is Secretary, Deborah (Gillette) Nagle is Treasurer and Dan Peck is our Recruiter. In past years Meg Roosma, Dale Hruby and Russ Robertson have served on the board). Class members on the board are George Lawton, Tony Bauer, Alan Chase and Frank Harlen, but as we enter Phase 3 in the next couple of years, assuming the Class approves an anticipated change in our By-Laws, we will replace two of our class members with descendants, starting a transition than all descendant board eventually.

Some questioned why there was a 7-year limit on membership. George explained that that policy was to broaden the involvement of our class. Someone reflected that it appears a needless constraint giving our advancing years. The response was that we would like to broaden the involvement of our kids, so it is still a useful guideline.

George said that the value of the PEF at this time is \$1,704,775. It has benefited from donations from the estates of Dick Oberg (\$20,000) and George Robertson (\$10,000).

Class Scribe (Pete Penczer) Pete said his goal is to distribute class notes once each month. Distribution occurs as follows: Pete gathers the material and forwards it to the AOG for formatting and posting the on AOG's web site. Pete Trainor then downloads the notes, copies them to our Class Web site, and provides a direct link to the posting via a class-wide e-mail.

Updating Personal Information with the AOG (Mike Daley) Mike reviewed an email from the West Point Society of Central Pennsylvania that provided guidance for updating personal records at West Point. An extract is provided:

- Consider updating your register entry. AOG will be publishing the Register of Graduates again in April 2021. To update your entry, log in to the WPAOG website (www.wpaog.org). Then go in succession to OLD GRADS, Update Your Profile and finally Update Your Register Entry. Painless!
- Consider sending a copy of your DD214 (if one is in your possession) to AOG <u>cullumfiles@wpaog.org</u>
- Consider updating your Cullum file. In the spring (thereabouts) of your graduation year, you had
 the opportunity to create a Cullum File maintained by AOG by filling out a form containing
 biographical information, parents and sibling names, hometown, HS attended, extracurricular
 activities and the branch selected. cullumfiles@wpaog.org

Class Lists. (Pete Trainor). Pete recommended that the penalty of removing a classmate from the authorized USMA1958@west-point.org list when the classmate uses "reply to all" be eliminated. The EXCOM agreed that the sentence: "Replies to all are not permitted and violators of these rules will have their sending privileges suspended without notification." should be removed.

If you are like me, you may not remember the definition of the three lists, so I'm repeating them here with the revised text for the usma1958@west-point.org list

- 58usma@west-point.org
 This is the "restricted" list, the list that only specified members of the class are allowed to send messages (Class President, List Moderator, Death Notices, EXCOM Chair, Vice Chair, & Secretary). It is the most complete list and has roughly 425 addresses. We use it for ONLY the monthly roster updates, death notifications, and important EXCOM notifications.
- 2. <u>usma1958@west-point.org</u> This is the "class" list, the list that was set up for the class back in 1996 and is for Class of 1958 subject matter only. "Replies to all" are permitted; however, this list is <u>not a forum per se</u>. Classmates should consider using "Reply to all" only if they feel that their post would be of some interest to many of the 350+ classmates and widows on the list. Otherwise, "Reply to Sender" may be more appropriate. If you wish to post something on this list that does not meet the strict criterion of class of '58 business, send the message to EXCOM Chair for a decision about posting the message on this list. If approved, EXCOM Chair will post it for the classmate in his name."
- 3. usma1958-forum@west-point.org This is the "forum," the wide open list. Any subject matter is permitted and replies to all are permitted. The only restriction is that postings should be in good taste and forego obscene language. This list has approximately 200 addresses

Memorial Articles (Bob Hayden) Bob reported that there are 120 classmates that have passed away with no memorial article. He expects that 12 or 13 MA's will be published in 2021. He expressed much of the same frustration that Lee Miller did in contacting next of kin. Twenty classmates have expressly said they do not want a MA.

Widow's Outreach Team. (Audrey Webb) Audrey provided extensive detail on the activities of the WOT. (see Attachment 3). There have been six deaths since our last meeting. Audrey, Barbara Raymond and Betsy Hall have all played roles in reaching out to the surviving spouse.

Audrey echoed the familiar refrain about the difficulty of contact information. Specifically she needs telephone numbers for the widow of deceased classmates so she can put into action the various WOT activities — condolence card, survivor's booklet, follow-on calls to provide help and invitation to widows' activities.

Class of 58 Mini Reunion 2020 New Orleans, Louisiana

Planning: In October 2019, planning was initiated to schedule a Mini Reunion in New Orleans at the World War II Museum's Higgins Hotel, May 26-28, 2020. By March 1, 2020, 60 classmates/widows had made reservations to attend. The total "head count" at the time was 120. The covid19 pandemic put a damper on the planning process that resulted in revising the dates for the reunion from May until November 1-3. These dates were selected after discussions with the hotel management and, obviously, overly optimistic tourism oriented city staff members who opined that by November "you should be good to go" for a group that size. On September 30th there were 24 classmates/widows with reservations for November, with an estimated total head count of 46. By October 26th that number had dwindled to 4 classmates, a "Final 4", for a total attendee count of 7. Unfortunately, on October 29th another dropped off the list. In a two day period we went from a "Final 4" to "3 Musketeers", Sands, Shepard and Stambaugh. Adding Barbara and Oksana to the list gave us total of 5 attendees, the "Fab 5". As you can tell, F-1 dominated the attendee count. The ultimate goal of the planning process was to ensure that, regardless of number, those that attended would "pass a good time" in the Crescent City. I believe that was accomplished.

Activities: We attempted to follow the same schedule of activities as outlined for the May dates:

Day 1(Arrival)

- 1000 Benny Havens available for mini registration in the Eisenhower Suite.
- 1800-1930 Welcome Reception Kilroy's (A number of WW2 Museum executives, including Dr. Gordon "Nick" Muller, Co-Founder/CEO Emeritus, Steve Watson, CEO and others)
- Dinner on your own
- Benny Havens open until 2400 (if needed)

Day 2

- Breakfast on your on
- 1000 -1100 WW2 Museum, Solomon Theater, welcome by Museum Staff and view "Beyond All Boundaries"
- Remainder of day open, visit Museum, shop, Company dinners, etc.
- 1200-2400 Benny Havens open

Day 3

- Breakfast on your own, visit Museum, Shop, Etc.
- Benny Havens Open 1000-1830 and 2230-2400
- 1830-2200 Memorial Service, Class Meeting and Dinner Hotel Arcadia Ballroom

Although we tried to accomplish the activities as scheduled, the when, where and how changed significantly. For example, there was no in Hotel "Welcome Reception", "Benny Havens" or "Memorial Service, Class Meeting and Dinner" as you will note from the "Results".

Results: Saturday, October 31st (Day 1 minus), Bill Shepard arrived, in the late afternoon, from San Diego after an arduous one stop change planes in Dallas, essentially, transcontinental journey. As a reward for his being the "most distance traveler", he was provided transportation from the airport to the Higgins and treated to an early dinner at "Le Baguette". Le Baguette is a small Vietnamese restaurant located in a residential area that serves excellent food. The Vietnamese owner and I were both stationed at Bien Hoa Air Base at the same time (66-67).

Sunday, November 1st (Day 1): Since Bill and Oksana Stambaugh were not scheduled to arrive until mid-afternoon, Bill Shepard and I decided to use our time wisely. We went to the Audubon Park Golf Course for 18 holes worth of exercise. To be on the safe side, we decided to invite a doctor, Charles Dupin, to join us. Charles is a former Navy Flight Surgeon who ensured we were able to complete the round without incident. After changing from golf to causal dinner acceptable attire Bill and I picked up the Stambaughs for a quick tour of uptown New Orleans to include Tulane. Bill Shepard spent two "tough" years attending Tulane courtesy of Uncle Sam. We then went to another major schedule change. The "Welcome Reception" was held at 1522 Short Street (the Sands) absent the Museum executives, et al. After "catching up", without discussing any issues that could not be solved on the spot, and fortified with the available liquid refreshments we went to a near-by restaurant, Cote Sud, for dinner. A photo of the assembled group is attached (minipic2). After a superb meal, the "out-of-towners" were able to view one of our 100+ year old pumps that help attempt to keep the city dry as well as one of the new public housing areas on the return to their lodgings. Bill and Oksana Stambaugh were staying at Le Belle Maison located a few blocks from the Museum.

Monday, November 2nd (Day2): We gathered at the Higgins and "marched" across the street to the Museum's Solomon Theater for the 1000 showing of "Beyond All Boundaries". Narrated by Tom Hanks, it is a 50 minute 4D presentation that provides a snapshot of the war years. After the movie, the "Fab 5" (minus 1, Barbara had other obligations) took a quick walk through the Museum to determine "what was where", had lunch in the Museum's American Sector Restaurant then dedicated the remainder of the time to independent touring. Although we did not have any of the Museum executives at either our "Welcome Reception" or "Boundaries" welcome, I was able to introduce our group to Dr. Nick Mueller, Museum Co-Founder, while we were in line ordering our lunch. In addition to the permanent exhibits, The D-Day Landings, Road to Berlin, Road to Tokyo and Arsenal of Democracy, at various times the Museum will host temporary exhibits. We were able to view two that were most interesting, "Remembered Light: Glass Fragments from WW2, The McDonald Windows" and "Ghost Army: The Combat Con Artist of WW2". "Light" is a collection or 25 art pieces that were constructed in 2003 from shards of glass collected in 44-45 from damaged or destroyed churches in England, France, The Netherlands, Belgium and Germany by Chaplain Fredrick McDonald. The permanent home of "Glass" will be the restored Post Chapel at the Presidio of San Francisco. "Ghost" told the story of the 23rd Headquarters Special Troops. Apparently the existence and activities of this unit, whose sole mission was to deceive the enemy, were classified until the 1990's. A PBS documentary was produced about the unit in 2013. The Museum exhibit was thorough and well done. The oral histories part of the exhibit featured George Rebh, Jan '43, who commanded a company in the 23rd. He served on the Commandant's Staff during our cadet days and retired as a Corps of Engineers MG. At 1700 we met at Rosie's, the Higgins' rooftop bar that provides a

great view of the city, in order to develop the appropriate attitude prior to a superb meal at Restaurant Peche, located a short distance from the hotel. By observing the attached photo taken in Rosie's (minipic3), you may confirm that our attitude had been properly adjusted. The photographer actually thought the camera was level.

Tuesday, November 3rd (Day 3): No official Mini activities were scheduled for the morning and early afternoon. Additional time was devoted to the Museum, in particular the Boeing Center. The Center houses a number of WW2 aircraft along with a display honoring each of those awarded the Medal of Honor in WW2. At 1630, I took the group on a tour of the Lake Pontchartrain area of the city to include a stop at Lakefront Airport. The airport was built in the 1930's and, at the time, was one of the most modern airports in the US. It was subjected to alterations over the years, especially after commercial air activities were relocated. However, after Hurricane Katrina, 2005, a decision was taken to restore Lakefront to its original art-deco design. Today it is a gorgeous facility. Private aviation operations are conducted at Lakefront and the WW2 Museum operates its PT 309 boat tour from a near-by marina. The terminal building contains a restaurant and is available for private parties. After viewing various aspects of the hurricane protection/drainage systems and harbor operations along the lake we arrived at Ralph's on the Park for our "Mini Closing Activities". Ralph's is delightful restaurant with a superb atmosphere located adjacent to City Park. Recognizing classmates that are no longer among us and enjoying the meal presented no problem for us. However, the conduct of a "Class Meeting" was a challenge. First of all, there was no one present with any authority to initiate a meeting; no Class Officer, no member of the ExCom, etc. A considerable amount of time was devoted to resolving this dilemma. We did not know if we should compare Cullum numbers or "draw straws" to determine who should initiate the meeting. From a "short straw (height perspective)", it was easy, F-1 vs K-1. So, I initiated the meeting. Since there was no agenda, it seemed appropriate to entertain a motion to adjourn. During the discussion associated with the motion, Bill Shepard and I thought we might have an idea that the ExCom might consider as a method of developing revenue to support the Class Perpetual Fund. We discovered that Dr. Stambaugh is not only a recognized intellectual but also a "Gentleman Farmer" of some renown. He is a prodigious producer of produce. Oksana devotes a considerable amount of time determining what to do with the volume of produce generated. In fact, after preparing all that can be reasonably consumed by family and guests, it appears a substantial amount is given to others free of charge. Since all of these agricultural activities occur within a reasonable distance of the DC area, it appears appropriate for the ExCom to consider options for utilizing a portion of the produce for the benefit of the Class. The condition precedent, obviously, is Bill Stambaugh's willingness to provide produce, without charge, for Class use. For example, the ExCom might consider establishing Produce Stands at one or more locations within the area. The cost of constructing and managing the stands would be a responsibility of the ExCom. Staffing the stands could be readily accommodated by establishing a duty roster based on the classmates in the area. Sales revenue generated would benefit the Perpetual Fund. Although a formal motion was not entertained at the Mini Reunion Class Meeting, we offer the results of the discussion for your consideration. It seems that one attendee raised questions regarding legality of the meeting, lack of approved process, etc. Before discussion was complete, the final round of drinks was served and the meeting faded away. The attached photo (minipic1) clearly demonstrates a good time was had by all.

Wednesday, November 4th (Day 4): Billed as the scheduled departure day, Bill Shepard was transported the New Orleans Airport for a late morning flight to San Diego via Dallas. Bill and Oksana Stambaugh elected to stay until Sunday, November 8th and were able to take advantage of what the city has to offer without the usual large crowds. Among the newest attractions added to the "things to do list" are the local distilleries. The Sezerac House, in particular, has a great whiskey tasting program. We had a pre-departure dinner together on Saturday, November 7th, at Mandina's, located in Mid-City. Mandina's is a long established and very popular restaurant among the locals.

Although we missed not having a large gathering, covid19 dictated that all stay safe and understand problems associated with travel. All of you were in our thoughts and we felt you among us in spirit. I recommend you add the WW2 Museum to your "Bucket List". It is truly a tribute to our fathers, uncles, aunts and etc. who were all members of the "Greatest Generation". In the near future, the Museum will "break ground" on the last of the buildings planned for the complex. The "Liberation Pavilion" will be three stories and dedicated to the years after the cessation of hostilities.
