### USMA 1958 Executive Committee Meeting, 6 December 2022

The EXCOM met virtually on 6 December 2022 at Andy Andreson's home. Andy, Lee Miller, and Church Hutton attended in person. Jack Bradshaw, Bob Hayden, Mike Mahler, Mike Daley, Pete Penczer, Pete Trainor, Tony Bauer, Audrey Webb, and Garry Roosma attended by phone.

#### 1. 65th Reunion 3-7 May 2023 (Garry Roosma)

Reunion planning is on track. The Park Ridge Marriott (Park Ridge NJ) has set aside 72 rooms, can set aside more, and classmates have so far reserved 60. Garry will send an email identifying those who have reserved there. The AOG will open a website in February with our Reunion schedule and registration details.

Andy has reserved a bus with 45 seats to take DC-area classmates to the Marriott. It departs the Arlington Army-Navy Club 1100 hrs. 3 May and returns on 7 May. Round-trip cost: about \$100 per person. Individuals should sign up with him.

There will be no major Class gifts to the Academy or AOG at this Reunion. Jack said we had served longer than many classes and thus had fewer major earners.

## 2. 2023 Class Social Activities (Andy Andreson)

We will lunch with the Class of '57 at the Ft. Myer Officer's Club in late February.

There will be no Class memorial service at the VN Memorial in May but there will be at the Reunion, where the names of all deceased classmates will be read aloud.

## 3. Vacant EXCOM Positions (Andy Andreson)

The EXCOM needs a Vice Chair, a Social Activities Chair, a 2d Regiment Death Notifications Rep., and a VN Memorial Service Rep. Andy and Jack will confer.

# 4. First Class Club (Mike Daley)

The Club has an area ready for the "Final Toast" Armagnac Andy will take to the Reunion. It will display behind glass in a wood box with a plaque reading "Final Toast Class of 1958," in the spirit of the Doolittle Raiders. No decisions have been made on who will drink it and when. The Class of 1983, which later will sponsor the Club, recently inspected it and is raising \$4.5M for future Club maintenance.

### 5. Perpetual Endowment Fund (Tony Bauer)

The market decline has dipped the Fund to now \$1,859K, but it should recover as and when the market does. Fund allocations are unchanged but under review.

Per a PEF Board decision in early 2022 to pass more responsibilities to Class descendants, Russ Robertson (George's son) will become the next Chairman. Tony and Frank Harlem will also remain on the Board for a few more years.

#### 6. Treasurer's Report (Lee Miller)

Our Gift Fund has also declined with the market, from \$157K to now \$138K.

After disbursements, Admin Fund assets minus liabilities now total: \$50,541.45. Liabilities include the \$25K obligated earlier to pay \$100 per classmate at death.

#### 7. <u>Death Notifications (Andy Andreson for Terry Connell)</u>

Ms. Meyers, AOG POC for death notices, and the family must approve memorial articles. The AOG will not accept a ring for a melt unless a memorial article is on file. Standby memorial articles should go <u>direct</u> to AOG, per established practice.

Bonnie Smith (Tony's widow) is on the AOG Survivors Committee, and Mike Daley has also advised and assisted for several classmate burials at West Point. Andy said we have now lost 314 classmates and have 259 living.

## 8. Women's Outreach Team (Audrey Webb)

The team assisted the widows of nine classmates who died since our last EXCOM. Audrey deeply appreciated the long assistance given by our late Frank Wascowicz.

## 9. Other

Jack is writing a paper describing USMA 1958 Class activities and practice beyond our 65<sup>th</sup> Reunion.

One other important topic is Frank Waskowicz, whom we lost this past August. Words could never express all of the work, talent and effort that Frank put into making the Widows Outreach Team both come to life and keep it going. The wonderful graphics, leadership, and advice of this fine man were and still are greatly appreciated and remembered.
