MEMORANDUM FOR United States Corps of Cadets, West Point, NY 10996

SUBJECT: 500th Night Event Privileges

1. The purpose of this memorandum is to outline the privileges afforded to Cadets for 500th Night events.
2. **Privileges.** All members of the Second Class are authorized the following:
 - a. Excusal from all guard duty from 1900 Thursday 18 January 2007, through 2330 Sunday 21 January 2007. All duty officer duties will be performed by the First and Third Class chain of command.
 - b. Rooms in PMI order.
 - c. TAPS for Second Class cadets is at 0100 on 20 January 2007 (Friday to Saturday) and on 21 January 2007 (Saturday to Sunday).
 - d. Non-chargeable pass for Second Class cadets **only**.
3. **Disciplinary Tours.** Second Class cadets who have tours from a regimental board or higher are **not** excused from serving tours during the weekend of 20-22 January 06.
4. **First and Third Class Dates.** First and Third Class cadets are authorized to attend 500th Night functions as dates of Second Class cadets, if they are not serving punishment that would prevent their attendance (e.g. restriction, loss of privileges). However, these First and Third Class cadets will attend all on-post official functions in the designated Cadet uniform. TAPS for First and Third Class cadet dates is at 0100 on 20 January 2007 (Friday to Saturday) and 0100 on Sunday, 21 January 2007 (Saturday to Sunday). Third Class cadets may use a **chargeable** pass for this event.
5. **Banquet.** Second Class cadets must sign in from privileges NLT 1800 Saturday, 20 January 2007 and attend the class banquet and hop. If cadets wish to resume privileges, they must again sign out in their unit departure book upon the completion of all official functions.
6. **Authorizations for Cadets Not in Good Standing.** Members of the Second Class who meet any of the following criteria are allowed Walking Privileges **only**:
 - a. Academic Probation (APST/APSC deficient)

b. Already serving restriction or loss of privileges punishment for a Regimental Article 10 or higher. Note: **These cadets are authorized Walking Privileges on 20 January 2007 only.** Punishment (restriction and loss of privileges) will be served on both 19 and 21 January 2007.

c. Referred to an honor investigation, conduct investigation (CI), or a Regulations USMA investigation by the Commandant or the Superintendent, or courts martial charges have been preferred against them.
