Enclosure 2: Report on the Perpetual Endowment Fund:

Fellow Classmates and Friends.

I am taking this opportunity to update our class on the Perpetual Endowment Fund, as time will be limited at the 50th Reunion for an in person presentation at the business meeting.

Exactly ten years ago, at our 40th Reunion, there was a presentation of a concept for a Perpetual Endowment -- an endowment which would outlive and honor our Class -- while providing significant support to the United States Military Academy. You might remember that there was a lively discussion. A few of you expressed your views. Church Hutton gave an impassioned argument as to why this proposal merited the full support of the class. He used the snowball analogy -- that our funds would grow like a snowball rolling down a snowy hill. His argument sealed the support of the class.

George Lawton, then Chairman of our Executive Committee, asked for a class vote. The class Endowment was born on that day.

The Class Perpetual Endowment is a unique gift befitting the Great class of 1958. Why?

- It is one of a kind. No other class has such an endowment.
- It is designed to outlive our class.
- It is managed by our classmates and graduated descendants -- not by the AOG.

Four 58ers drafted the bylaws for the endowment -- Church Hutton, Lee Miller, Chuck Hansult and Ed Weckel. Afterwards, the bylaws were approved by a class vote and jointly signed by the Chairman of the EXCOM and the Endowment Board.

The Endowment Board was originally made up of four classmates -- Church Hutton, Lee Miller, Pete Brintnall and Ed Weckel. In addition, there was one descendant member -- Meg Roosma, the First Captain from the class of 1998 -- Patrick Connelly, and a recent grad from the Academy currently serving at West Point. It was recognized at the outset that the Board had to represent the Class, while at the same time gradually shift its power to our descendants.

As to the first point, there has been a natural turnover of power from original board members. Hutton, Brintnall and Miller have been replaced by John Evans, Bob Rhodes and John Nun. Weckel is serving the last year of his term and will be replaced in October by a member elected by the class. The Board has had three Chairmen -- Weckel, Brintnall and Evans - - each of whom has placed his individual stamp on the Board.

As to the second point, - - gradually shifting power to our descendants. Meg Roosma will shortly become the Treasurer. A second descendant member position was recently added to the Board, and Dale Hruby's son, Dale II, has assumed this position. Dale II has been charged with maintaining contact with our descendant children and grandchildren so they can step into our shoes in a few years.

Lastly, Patrick Connelly, First Captain of '98 will be replaced by the First Captain from the class of 2008 (Jason Crabtree), when he graduates. Patrick will remain an emeritus member of the Board, as will all future First Captain Board members.

No report would be complete without a funding overview.

First off -- our goal:

The Class Executive Committee established an initial goal of \$580,000 by June 2008 during their October 2001 meeting. This was suggested by George Sibert and approved by the EXCOM. In addition, a goal of 100 percent participation was suggested.

Currently, 501 members have contributed to the Endowment. This figure includes donations made by classmates and spouses in memory of deceased members of the class. Donations range from \$7.00 to over \$100,000. Thus far, the amount contributed is \$430,352. Our endowment is worth \$644,050 as of May 6, 2008. We are currently 20 percent invested in foreign market mutual funds and the remainder between large cap and small cap mutual funds managed by Fidelity Investments.

The last item I want to address is legacy gifts. The next time you rewrite your Will or Trust, why not consider leaving a gift to the rolling snowball as it gains size in the future. Thus far, we are aware of over \$70,000 in legacy donations earmarked for the Endowment. If you are interested in a legacy gift, the following wording can be used:

"I bequest \$X0,000(or Y shares of stock, etc.) of my residual estate to the Fidelity Investment Charitable Gift Fund, to be added to the USMA Class of 1958 Perpetual Endowment, account number CGF 51034, attention: Contributions Dept, PO Box 770001, Cincinnati, OH 45277."

In conclusion, Lee Miller will announce the results of the "Banker's Trophy" contest at the 50th Reunion Class Business meeting.
