Chairman, Jerry Mitchell, called the meeting to order at approximately 1900 hours.

SUBJECT #1: 2015 Meeting Minutes

SUBJECT #2: 2014 Perpetual Endowment Fund Meeting Minutes

DISCUSSION: George Lawton made a motion that the 2015 minutes be amended to change Jason Crabtree's title from "Trustee Emeritus" to "Designated Member." George stated that in accordance with the PEF bylaws, Jason will not achieve the "Trustee Emeritus" title until the class of 2018 graduates, when the next "Designated Member" joins the board. The Designated Member is a full voting member. The Trustee Emeritus only votes when there are changes to the by-laws or funding allocations. After

this discussion John Nun made a motion that the 2015 minutes, provided to each attendee and available on the class website, be approved once amended. The motion was approved.

SUBJECT #3: Class of 1958 Membership on PEF Board

DISCUSSION: The PEF by-laws direct the board membership should contain four members of USMA '58. Currently only two members are on the board. At today's meeting, Jerry Mitchell invited George Lawton and Alan Chase to participate, and the board approved the action for Jerry to solicit approval from the Class to add George and Alan as board members to fill the empty positions.

SUBJECT #4: Perpetual Endowment Fund Treasurer's Report

DISCUSSION: Russ Robertson, Board Treasurer, presented the status of the Perpetual Endowment Funds (see Attachment 1). Russ reported that reported that six classmates currently have the Endowment Fund included on estate documents for a total of \$134,958.



Chairman, Jerry Mitchell, called the meeting to order at approximately 1900 hours.

SUBJECT #1: 2014 Perpetual Endowment Fund Meeting Minutes

DISCUSSION: John Nun made a motion that the 2014 minutes, provided to each attendee and available on the class website, be approved as written. The motion was approved.

Once the 2014 Minutes were approved, Jerry Mitchell reviewed the minutes verbally, and stated that the 2014 Minutes are the plan for the Perpetual Endowment Fund, leading up to the events in 2058. (See attachment 3.)

Dale Hruby asked the board to consider methods to maintain the '58 descendent list as '58 graduates perish. Elena Ivanova stated that the

Association of Graduates has the capability to generate a report through the Advancement Services Office, which tracks graduate relationships.

SUBJECT #2: Status of First Class Club

DISCUSSION: The PEF approved spending \$100,000 for a glass enclosure at the First Class Club in 2012. From the original \$100,000, approximately \$25,000 remains unobligated. Jason Crabtree made a motion that contingent on USMA '58 raising at least \$275,000 of the required \$300,000 for the club improvements, the PEF will authorize the donation of up to \$24,450 remaining from the original \$100,000 authorization to cover any shortfall after the raised funds are expended. [The intent of the Board is to cover any shortfall up to the limit of the remaining unobligated donation and that the fundraising effort would cover as much of the \$300K as it could, hopefully the whole bill.] The motion was approved.

USMA 1983 will assume responsibility for maintaining the First Class Club after a formal turnover from USMA 1958 at a time to be determined once repairs are completed.

SUBJECT #3: Fund Raising Idea from Mini-Reunion

DISCUSSION: During the recent mini-reunion, a classmate asked if there was a possibility to borrow against the funds in the PEF, if the class member planned to make a donation in a will. After much discussion, this subject was tabled without a motion.

SUBJECT #4: Perpetual Endowment Fund Treasurer's Report

DISCUSSION: Russ Robertson, Board Treasurer, presented the status of the Perpetual Endowment Funds (see Attachment 1). Russ reported that contributions this year of \$4,360 were not quite as strong as last year (\$5,290), with the March Back campaign continuing to be the main driver. He also reported that six classmates currently have the Endowment Fund included on estate documents for a total of \$134,958.

After presenting the Treasurer's Report, Russ Robertson made two motions:

- Motion to "rebalance" the investment funds by moving 3% out of the US equity/total stock market funds and placing those funds into the international fund. This motion was approved.
- Motion to put the international pool into an international "index" fund, which has outperformed the actively managed pool. The expense ratio for the current fund is 1.04% versus 0.17% for the index fund which does impact performance. This motion was approved.

- a. The Endowment is back to positive numbers so far this year. The markets have seen a lot of volatility recently, especially the international markets. Main drivers:
 - 1) China's slowing growth (fears of world-wide recession)
 - 2) Migration crisis in Europe
 - 3) Greece and Brazil (among other emerging market credit concerns)
 - 4) Russia's involvement in the Middle East
 - 5) The Federal Reserve's pending interest rate decision
- b. The good news is the US economy which is slowly improving. This is one of the reasons for the strong dollar which puts pressure on foreign currency (and international investments).
- c. I typically rebalance the funds by putting any new contributions into the fund that was most underweight from its target. This has worked well over the past few years. However, with the recent significant outperformance of the US stock market as well as the strong dollar, the board should consider whether we want to "rebalance" the pools right now. The strategy would have the Treasurer move 3% out of the US equity/total stock market funds and place those funds into the international fund (while it is cheap).
- d. One other proposal is to put the international pool into an international "index" fund, which has outperformed the actively managed pool. The expense ratio for the current fund is 1.04% versus 0.17% for the index fund which does impact performance.
- e. \$4,360 of contributions this year not quite as strong as last year (\$5,290) The March Back campaign continues to be the main driver.
- f. Six classmates currently have the Endowment Fund included on estate documents for a total of \$134,958.
- g. The fund makes an annual contribution of \$50 to the Class of 1958 Fund every June 6th, beginning in 2011. This helps satisfy a seven-year gifting requirement of \$250.

SUBJECT #4: Permanent Endowment Fund (PEF) Board activities supporting the first major disbursement of funds from the PEF, and the opening of the USMA Class of 1958 Time Capsule on the 100th Anniversary of our Graduation during May of 2058

DISCUSSION: The PEF Board will be the only functioning entity of the Class of 1958 as the years pass. The PEF Board will coordinate and organize the events in May of 2058 with the USMA Classes of 1998 and 2008 who will be celebrating their 60th and 50th Anniversaries respectively at West Point.

The current PEF Board is as follows:

Gerald 'Jerry' Mitchell (Chairman USMA 1958),

Russell 'Russ' Robertson (Treasurer, Descendent Member, USMA 1982), Jason Crehtree (Trustee Emeritus USMA 2008)

Crabtree (Trustee Emeritus, USMA 2008),

John Nun (Past Chairman USMA 1958),

Valerie Coffey (Secretary, Descendent Member, USMA 1985),

Elena Ivanova (Designated Member, USMA 1999),

Dale Hruby II (Descendent Member, USMA 1983),

William 'Pat' Connelly (Trustee Emeritus, USMA 1998).

Elena Ivanova is our AOG designated member, and William Connelly and Jason Crabtree are our Trustees Emeritus, and distinguished members of the Class of 1998 and 2008 respectively. The PEF Board will change in the coming years. When the Class of 1958 Executive Committee decides to disband in the coming years, the USMA 1958 members of the PEF Board will also step down, and be replaced by descendants of USMA 1958.

When our current AOG member steps down she will be replaced by another member of the AOG, preferably also a USMA Grad, and our current trustees emeritus decide to step down they should also be replaced by other distinguished members of their class. The AOG member and the trustees emeritus have no term limits. Other members of the PEF Board are limited to two six year terms per the PEF Bylaws. This explains how the PEF functions up to and through 2058.

A summary of some of the ideas that Jack Downing and others suggested might take place during our 100th anniversary and the 60th and 50th anniversary of the classes of 1998 and 2008, and the first major disbursement of funds from the PEF per the PEF Bylaws, and the opening and perhaps reburial of the USMA 1958 Time Capsule are discussed below.

SUBJECT #5: **USMA 1958 Permanent Endowment Board and the activities** surrounding the first major disbursement from the PEF and the opening of the **USMA 1958 Time Capsule in 2058**

DISCUSSION: The PEB will be the coordinating group for all activities. The events will take place in May 2058 along with the USMA 2008 50th Reunion and all activities should be coordinated with that class and the AOG.

All USMA 1958 descendants should be given an opportunity to attend the events. Classmates and widows of classmates should inform their children and grandchildren of the events to take place in May 2058 with instructions of how to contact the USMA AOG so that they can attend the 2058 events. A suggested letter to descendants is at Attachment 4.

This is not an official Academy event, and it is meant to be "low-key" so as not to inconvenience the class of 2008 that will be celebrating their 50th reunion, the AOG, or the Academy. That having been said, the Superintendent should be notified and be invited to address the group. This would also be an opportunity for the PEB to present the Superintendent with a check for the first major disbursement from the PEF.

The PEB might consider hosting a cocktail hour/mixer in the area prior to the official events where our descendants will have a chance to meet each other. The PEB might also arrange for USMA descendants who are cadets or recent graduates to lead tours of the academy grounds. The expenses for this could be borne by the PEF.

This will require early coordination by the PEB with the AOG, however the only involvement of the AOG is to refer descendants who call, to a point of contact in the PEB. The point of contact in the PEB will be the source of all knowledge required by descendants attending the events.

Elena Ivanova will put the PEF documents on the AOG server to establish a formal record of the PEF evolution. The time capsule is buried behind AOG; there is a paver marking the location. Items contained in the time capsule are listed in Attachment 5.

Draft Letter for Your Grandchildren

On the 50th anniversary of our graduation from West Point (in 2008) we buried a Time Capsule to be unearthed in 2058. Also, that is the year that our Perpetual Endowment Fund will make its first donation to West Point. The Class of 2008, with whom we have a special, close relationship, will celebrate its 50th graduation anniversary. All of which makes 2058 a special year.

None of us will be around to celebrate, but our grandchildren may be, and we have made some preliminary plans to encourage them to remember us at West Point. Two groups we know will likely still be in existence: the West Point Association of Graduates (WPAOG) and the '58 Perpetual Endowment Board (PEB). These have both agreed to help. The PEB will be the action agency and the WPAOG will act as directing agency for our grandchildren.

It would be virtually impossible to track the whereabouts of our descendants, but you can leave some directions for them to contact the WPAOG in early 2058. WPAOG will then direct them to the PEB.

To assist you in this, here is a draft letter for you to leave for your grandchildren (and great grandchildren) with some directions. I suggest you modify the draft to suit your circumstances, put it in a strong envelope and, with a class coin if you have one, pass it on to those who follow.

Dear Grandson/daughter (use appropriate name)

This is (your name) writing to you from (date). Happy New Year 2058!

I wish I could be with you to celebrate this event; however, that is quite impossible. I do remember when you were born, and how happy I was to have our family line extended far into the future. Do you remember when we used to go (personalize this - - hiking, biking, swimming, camping, hunting, etc., etc?). These were some of my fondest memories, which I always cherished.

I want to take you back 100 years - - to 1958, the year I graduated from West Point. I don't know if you realize how important West Point was in our family history, because (personalize this - - it is here that I met/married your grandmother, started my career, etc., etc). In those days we were concerned about the onset of the nuclear age, the frightening aspect of World War III and the spread of communism

throughout the free world. We were depression babies and molded by the events of World War II. We witnessed the collapse of the Soviet Union and the subsequent rise of militant Islam. We fought in the conflict in Viet Nam. The world certainly changed during our lifetime, and I suspect during yours. I cannot imagine the challenges and opportunities which you now face, but I hope it is a better world, helped in part by the sacrifices made by our Class during our careers.

We are very proud of our class. We are all men, since in those days women were not allowed in West Point. We all spent four years together and grew from boys to men. We then served together in both the Air Force (this was before the Air Force Academy) and the Army. As we took wives and children and grandchildren came, we bonded at our reunions. Even when we died, we wrote each others' memorial articles and stood by at our funerals. We shared a loyalty to the West Point motto, Duty, Honor, Country.

We have planned for two events to occur at our 100th Anniversary - - 2058, first, at the 50th Anniversary of our graduation, we buried a time capsule at West Point, which is to be unearthed then. It contains mementos from our days at West Point, such as items from our graduation, a "Bugle Notes" better known as the "Plebe Bible", a slide rule, a "Hop Card" and a plebe B-robe. I know that some of these are foreign to you, but I want to stir your interest.

Second, at this event, a substantial portion of our Perpetual Endowment Fund will be gifted to West Point - - the first of many gifts that will continue at 10 year intervals. (At our 40th Anniversary, we established a perpetual endowment, to be managed by our descendants, with the first major presentation to be made at our 100th Anniversary.)

During the unearthing ceremony, and the presentation of our class gift, we hope there will be an appropriate ceremony, attended by our descendants. We cannot be there, but we hope that our descendants will celebrate this occasion for us.

The year 2058 is also the 50th anniversary of the graduation of the class of 2008 and we hope that they will also be at the opening of the Time Capsule since they too have items in it. We had a special association with this class. We attended many of the events in their cadet life from their entrance to their graduation. We got to know many of them as cadets and some afterward, even as they recuperated from their injuries in the Iraq and Afghanistan wars. Some may remember us.

The purpose of this letter is to remind you of your grandparents and to share our pride in having served our country. An opportunity awaits you to attend our 100th

Anniversary at West Point. I would be pleased if you would contact the Academy (the West Point Association of Graduates-WPAOG, if it is still in existence) and determine when this event will take place. It probably will be in May, 2058, but schedules change over the years. The WPAOG should be able to put you in contact with the Perpetual Endowment Fund Board that will manage this event. I encourage you and your family (which is my extended family too) to attend and help us celebrate.

You are our connection with the world that follows us. In the words of "The Corps", a well known West Point anthem, "Grip hands, though it be from the shadows" and remember that we live in your memories.
